ADMISSION PROCESS

GENERAL INFORMATION

Apply: A student applying for admission to Lincoln Preparatory School for the 2019-2020 school year must complete a Student Application for Admission. Applications for the 2019-2020 school year Open-Enrollment Period are accepted 9:00 a.m., Tuesday, April 16, 2019, through 3:00 p.m., Friday, May 31, 2019. Lottery: If there are more Eligible Applicants than available spaces in a particular grade, then a lottery will be conducted on the campus of Lincoln Preparatory School, at 1:00 pm Monday, June 10, 2019. Students not offered a seat following the lottery will be placed on a waiting list based on their lottery position. Returning students that do not complete an Application prior to the New Student lottery will be placed on the waiting list.

Waiting List: If a vacancy arises before or during the 2019-2020 school year, the next Eligible Applicant on the waiting list will be offered admission and then removed from the waiting list.

Enrollment Packet: ALL returning students will be required to complete a Returning Student Enrollment Packet and a new health information card.
